L-Ilment

- Permezz ta' ittra datata 3 ta' Marzu 2021 (annessa u mmarkata bħala Dokument A), Dr Robert Aquilina, President tal-għaqda voluntarja Repubblika (l-Ilmentatur) talabni ninvestiga l-aġir tas-Sur Nigel Vella, dak iż-żmien Deputy Head of Government Communications fl-Uffiċċju tal-Prim Ministro. L-Ilmentatur allega illi s-Sur Vella kien qed jokkupa żewġ karigi full-time mal-gvern.
- Qed nirriproduċi l-kontenut tal-ilment hawn taħt, fejn l-Ilmentatur qajjem is-segwenti punti:

- Ma hemm l-ebda provvediment għall-kariga ta' Deputat Kap tal-Komunikazzjoni fl-Uffiċċju tal-Prim Ministro, okkupata mis-Sur Vella, u dan il-post ma jissemmiex fil-“Maximum Staff compliment for the Prime Minister’s Secretariat” (7.7.4);*
- 7.6.1 jipprovdli li “A Ministry that has no Parliamentary Secretariat is entitled to four Policy Consultants”. It-tweġiba għall-Mistoqsija Parlamentari 19216 tista’ tagħti x’jifhem li fil-Ministeru għal Għawdex hemm sitt policy consultants, wieħed minnhom is-Sur Nigel Vella, għalkemm ismu huwa moħbi fuq is-sit tal-Parlament. Huwa minnu li*



dawn is-sitta jistgħu ma jaqbżux l-erbgħha “full time equivalents” imma dan ma nistgħux inkunu nafuh.

3. *7.7.8 jistipula li kull applikazzjoni għall-ħatra ta’ Policy Consultant, bħal dik tas-Sur Nigel Vella, trid tkun approvata mill-Kap tas-Segretarjat tal-Prim Ministru. Allura din il-ħatra, li dwarha qed nilmentaw, kienet approvata minn persuna ta’ fiduċja oħra, il-Kap tas-Segretarjat tal-Prim Ministru.*

4. *7.8.11 hija čara li “All Secretariat employees are required to conform to the Code of Ethics for Public Officers or any other Code of Ethics as prescribed by law as the case may be. In line with this Code, all officers must first obtain the written recommendation of the Head of Secretariat of the Ministry, and then obtain the written approval of the Permanent Secretary of the Ministry concerned if they wish to take on any form of outside employment or business interest in addition to their Secretariat duties”. Għalhekk jidhrilna li f’dan il-każ hemm potenzjalment imġieba skorretta kemm mis-Sur Vella innifsu kif ukoll mis-Segretarju Permanenti Ewlieni u mis-Segretarju Permanenti fil-Ministeru għal Għawdex.*

Applikabbiltà tal-Att dwar Standards fil-Ħajja Pubblika

3. L-Att dwar Standards fil-Ħajja Pubblika (il-kapitolu 570 tal-ligijiet ta’ Malta) jagħtini s-setgħa li ninvestiga l-aġir ta’ membri parlamentari (inkluż ministri u segretarji parlamentari) u persuni ta’ fiduċja. L-Att jiddefinixxi “persuni ta’ fiduċja” bħala persuni li jaħdmu fis-segretarjat ta’ ministru jew segretarju parlamentari, u li jaġixxu bħala konsulenti, jagħtu pariri, jew jaġixxu f’kapacità eżekuttiva.

4. La s-Segretarju Permanenti Ewlieni u lanqas is-Segretarju Permanenti fil-Ministeru għal Għawdex ma jistgħu jitqiesu persuni ta’ fiduċja skont din id-definizzjoni. Għaldaqstant l-ilment mħuwiex ammessibbli fir-rigward tagħhom.

5. Mill-banda l-oħra, il-kariga ta’ Deputy Head of Government Communications hija koperta mill-Att, billi din hija kariga ta’ fiduċja fis-Segretarjat tal-Prim Ministru, u kif inhi wkoll il-kariga ta’ Policy Consultant ma’ kwalunkwe ministru. L-istess jgħodd ukoll għall-kariga ta’ Kap tas-Segretarjat tal-Prim Ministru.



6. Għaldaqstant l-ilment huwa potenzjalment ammessibbli skont l-Att safejn jittratta dwar is-Sur Nigel Vella u l-Kap tas-Segretarjat tal-Prim Ministru.

Indaġni Preliminari

7. Iddeċidejt li qabel ma ngħaddi biex nikkunsidra liema dispożizzjonijiet tal-kodiċi ta' etika relevanti¹ huma potenzjalment applikabbli għal dan il-każ, għandi niddetermina jekk hemmx bażi fattwali għall-ilment.

8. Għal din ir-raġuni, fit-18 ta' Marzu 2021 jiena ktibt lis-Sur Nigel Vella (kopja tal-ittra annessa u mmarkata bħala Dokument B) u tlabtu jipprovvdili informazzjoni kif jidher hawn taħt:

- (a) *tindika jekk hux minnu li inti okkupajt il-karigi indikati, u jekk iva, b'liema kondizzjonijiet;*
- (b) *tispeċifika jekk il-Ministeru għal Għawdex talabx approvazzjoni mill-Uffiċċju tal-Prim Ministru għall-ingaġġ tiegħek bħala konsulent, u jekk din l-approvazzjoni ngħataxt;*
- (c) *tispeċifika jekk inti tħabtx permess qabel aċċettajt il-kariga ta' konsulent fil-Ministeru għal Għawdex , u jekk iva, mingħand min tħalt il-permess u x'kienet ir-risposta.*

9. Jiena rreferejt għad-dokument intitolat *Manual on Resourcing Policies and Procedures*, ippubblikat mill-Uffiċċju tas-Segretarju Permanenti Ewlieni, li jirregola l-proċess tal-ħatra ta' impjegati mal-gvern.² Il-kapitolu 7 ta' dan id-dokument jittratta dwar l-ingaġġ ta' persuni ta' fiduċja.

10. Irreferejt għat-taqṣima 7.8.11 tal-*Manual on Resourcing Policies and Procedures*, intitolat “*Other Employment or Business Interests for Secretariat Staff*”, li jgħid illi:

All Secretariat employees are required to conform to the Code of Ethics for Public Officers or any other Code of Ethics as prescribed by law as the case may be. In line with this Code, all officers must first obtain the written recommendation of the Head of Secretariat of the Ministry, and then obtain the written approval of the Permanent Secretary of the Ministry concerned if they wish to take on any form of outside employment or business interest in addition to their Secretariat duties. This requirement also applies to any parttime employment or business interest that an individual may have held prior to taking up a Secretariat post and which he/she may wish to retain. Employees are to seek renewal of such approval on an annual basis.

The procedure to be followed in these cases is for the individual to declare any outside employment or business interest in writing to the Head of Secretariat for his/her recommendation to the Permanent Secretary of the Ministry concerned. With particular reference to the conflict of interest issue highlighted in the above-mentioned Code, the Permanent Secretary is then to issue a written decision to the Head of Secretariat as to whether the Officer's request is approved or denied.

The Permanent Secretary's final response, including the officer's declaration supported by the Head of Secretariat's recommendation, is to be copied to the Cabinet Secretary and the Office of the Prime Minister. In cases that concern new recruits to a Secretariat, this procedure must be completed before OPM approval for recruitment is obtained and the Secretariat Agreement signed.

Sottomissjonijiet bil-Miktub

11. Is-Sur Vella rrisponda permezz ta' email datata 23 ta' Marzu 2021 (annessa u mmarkata bħala Dok Ċ), fejn qal:

Nibda biex ngħid mill-ewwel li jiena la għandi u qatt ma kelli żewġ xogħolijiet full-time fl-istess ħin.

Il-kuntratt tiegħi full-time kien biss dak bħala Deputat Kap tal-Komunikazzjoni tal-Gvern fl-Uffiċċju tal-Prim Ministru, liema kuntratt ma baqax fis-seħħi mit-22 ta' Marzu minħabba li ridt niffoka fuq prospetti differenti fil-karriera tiegħi. Kuntrarjament għal dak li ġie vvintat, nispecifika li l-konsulenza tiegħi mal-Ministru għal Għawdex kienet ta'



għaxar sigħat (10) fil-ġimgħa, u għalhekk kompletament fuq bażi part-time.

Għall-fini ta' verifika qed nehmeż ma' din il-korrispondenza kopja tal-kuntratt mal-Ministeru għal Għawdex (immarkat u anness Dok A). Qed nehmeż ukoll l-estensjoni ta' dan il-kuntratt (immarkata u anness Dok B).

L-ingaġġ tiegħi bħala Deputat Kap tal-Kommunikazzjoni sar skont il-proċeduri u l-manwal li jirregola tali ħatriet. Bl-istess mod sar l-ingaġġ fuq bażi part-time fi ħdan il-Ministeru għall-Għawdex. Għall-fini ta' verifika qed nehmeż ma' din il-korrispondenza kopja tal-korrispondenza mibgħuta lill-uffiċċju tal-Kap tas-Segretarjat tal-Uffiċċju tal-Prim Ministru mill-Ministeru għal Għawdex (immarkata Dok Ċ).

Konsiderazzjonijiet

12. L-ilment huwa bbażat fuq żewġ allegazzjonijiet:

- li s-Sur Vella kien qiegħed jokkupa żewġ karigi fuq bażi full-time; u
- is-Sur Vella naqas milli jakkwista l-approvazzjonijiet meħtieġa mill-kapitolu 7 tal-*Manual on Resourcing Policies and Procedures* qabel ma assuma l-inkarigu ta' Policy Consultant mal-Ministeru għal Għawdex.

13. Fir-rigward tal-ewwel allegazzjoni, jidher čar illi l-kuntratt tas-Sur Vella bħala Policy Consultant mal-Ministeru għal Għawdex huwa purament fuq bażi part time u jinvolvi biss għaxar siegħat fil-ġimgħa.

14. Fir-rigward tat-tieni ilment, il-proċedura elenkata fit-taqSIMA 7.8.11 tal-*Manual* titlob approvazzjoni mingħand il-Kap tas-Segretarjat u s-Segretarju Permanenti fil-ministeru fejn jaħdem membru ta' segretarjat li bi ħsiebu jassumi xogħol ieħor. Is-Sur Vella kien jaħdem fl-Uffiċċju tal-Prim Ministru u għaldaqstant kellu bżonn l-approvazzjoni tal-Kap tas-Segretarjat tal-Prim Ministru u s-Segretarju Permanenti Ewljeni.

15. Mill-korrispondenza pprovduta mis-Sur Vella, jidher li l-Kap tas-Segretarjat tal-Prim Ministru approva l-ingaġġ tas-Sur Vella bħala Policy Consultant mal-Ministeru għal Għawdex. Jidher ukoll li l-kuntratt tas-Sur Vella bħala Policy Consultant ġie riferut lid-Direttur (Management Support) fl-Uffiċċju tal-Prim Ministru. Il-kariga ta' Direttur (Management Support) taqa'



direttament taħt is-Segretarju Permanenti Ewlieni,³ jiġifieri l-uffiċċju tas-Segretarju Permanenti Ewlieni ġie infurmat bl-ingaġġ tas-Sur Vella bħala Policy Consultant.

16. Jidher li dawn ir-riferenzi saru għall-finijiet ta' dispożizzjonijiet oħra tal-Manual, mhux it-taqSIMA 7.8.11, iżda certament ma jistax jingħad li s-Sur Vella b'xi mod aġixxa minn wara dahar is-superjuri tiegħu. Dawk li, skont it-taqSIMA 7.8.11 tal-*Manual*, kellhom japprova l-ingaġġ tiegħu bħala Policy Consultant għamlu dan, jew tal-anqas gew infurmati u setgħu joġżejjonaw kieku xtaqu. Għaldaqstant jien tal-fehma li fis-sustanza r-rekwiziti tat-taqSIMA 7.8.11 tal-*Manual* gew sodisfatti, u jkun tfettil jekk wieħed jikkonkludi li kien hemm ksur ta' etika għas-sespliċi raġuni li l-proċedura applikabbli ma ġietx segwita b'mod preċiż.

17. L-Ilmentatur iqajjem ukoll il-punt li l-kariga ewlenija tas-Sur Vella, dik ta' Deputy Head of Government Communications, mhix inkluża fil-*Manual*. Dan jidher li huwa minnu, iżda l-ħolqien ta' din il-kariga ma jistax b'mod raġonevoli jitqies bħala nuqqas da parti tas-Sur Vella jew il-Kap tas-Segretarjat tiegħu. Barra minn hekk, il-paragrafu 7.7.7(b) tal-*Manual* jaħseb għal varjazzjonijiet fl-istrutturi tas-segretarjati. Dan il-paragrafu jgħid hekk:

In view of the exigencies and work practices of different Ministries, a Minister, Parliamentary Secretary and other designated Offices may request the Prime Minister's approval to modify the set up of the complement in the tables shown above. These changes should be such as not to unduly upset the salary allocation of the Ministry's Private Secretariat, albeit that a reasonable flexibility in salary scales and other benefits will be allowed, as long as the approved budget is not exceeded and the number of personnel in the respective secretariat remains the same.

Konklużjoni

18. Għal dawn ir-raġunijiet jiena ddecidejt ai termini tal-artikolu 17(1) tal-Att dwar Standards fil-Hajja Pubblika li m'hemmx bażi biex dan l-ilment jiġi investigat.

20. Dan id-dokument jirrapreżenta deċiżjoni li mhux se ssir investigazzjoni, u mhux rapport dwar l-eżitu ta' investigazzjoni. Għaldaqstant, b'konformità mal-proċedura maqbula fil-Kunitat Permanenti tal-Parlament dwar l-Istandards fil-Ħajja Pubblika, dan id-dokument mhux se jiġi ppubblikat mill-ufficċju tiegħi, iżda dan naturalment ma jorbotx lill-partijiet.

**AGREEMENT FOR THE ENGAGEMENT OF A POLICY CONSULTANT ON A
PERSON OF TRUST BASIS
WITH THE MINISTRY FOR GOZO**

It is to be noted that nomenclatures importing the male gender include also the female gender.

1. Agreement made on the 12th February 2020 between the Government of Malta, represented by John Borg, Permanent Secretary within the Ministry for Gozo and Mr. Nigel Vella of [REDACTED], hereinafter called the Policy Consultant for services to be rendered to the Ministry for Gozo for any duties which may be assigned to him by the Minister.
2. The Policy Consultant, which hereinafter is being engaged on a Person of Trust basis, undertakes to perform his duties faithfully and diligently for a period of one year and will act in all respects according to the instructions or directives given to him by the Minister.
3. The agreement is effective for a period of one year as from the 1st February 2020.
4. Since, for the purpose of S.L. 452.81 entitled Contracts of Services for a Fixed Term Regulations 2007 there is an objective reason why an incumbent in this position should not attain indefinite status if employed in excess of the legal limit stipulated in these Regulations, this being the fact that he is engaged on a Person of Trust basis. In the event that the contract is not renewed or is terminated, the Contractee's service with Government will hence be terminated.
5. The Policy Consultant shall, unless otherwise requested by the Minister, perform the following duties:
 - Responsible for strategy and communications in relation to the Ministry for Gozo and Gozo affairs
 - Other matters within the Ministry for Gozo
6. The Policy Consultant shall be expected to work an average of 10 hours per week and any additional periods according to the exigencies of the Ministry; however, he will not be entitled to any extra remuneration.
7. The salary of the Policy Consultant shall be salary scale 3, paid pro-rata according to the number of hours stipulated in Clause 6 of this agreement.
 - 7.1 Furthermore, the Policy Consultant shall be entitled to the following benefits:
 - Expertise Allowance of €2,000 per annum
 - Expense Allowance of €500 per annum
 - Mobile & ADSL Connection Allowance of €203.75 per annum
 - Car Allowance of €2,320 per annum
8. The Policy Consultant is expressly prohibited from participating in any way in all forms of tenders for supply and other forms of service and / or supply purchase requests issued by the Ministry.

9. If the Policy Consultant shall be compelled by reason of ill-health (not caused by his own misconduct) to resign office or if at any time it shall be certified by a duly qualified medical officer employed by the Government that he is incapable by reason of any infirmity of mind and body (not caused by his own misconduct) of rendering further effective service, the salary shall be paid up to date of such resignation or certificate.

10. The Policy Consultant shall be entitled full-pay sick leave for thirty working days and half-pay sick leave for a similar period or pro rata periods in the case of Policy Consultants working on a part-time basis. A certificate signed by a duly qualified medical officer employed by the Government shall be the conclusive evidence on the question as to whether the Policy Consultant was compelled to resign his office by reason of ill-health within the meaning of Clause 11 of this Agreement.

11. The Policy Consultant shall be entitled to 216 hours vacation leave on full pay or pro rata periods in the case of Policy Consultants working on a part-time basis to be availed of on such days as the Minister shall approve.

12. Any unutilised vacation leave is forfeited unless availed of by the expiration of the contractual period. The Contractee may opt to donate such leave to the Donation of Vacation Leave Central Fund.

13. The Policy Consultant will not be entitled to any other benefits apart from those stipulated in the preceding paragraphs. The Policy Consultant will not be entitled to such concessions applicable to permanent public officers as parental leave, responsibility leave and reduced hours.

14. The Policy Consultant shall conform to general Government rules and regulations in force from time to time.

15. If the Policy Consultant shall at any time after signing hereof, neglect or refuse for any cause (other than ill-health not caused by his own misconduct) or become unable to perform any of his duties or to comply with any order, or shall disclose any information respecting the affairs of the Government to any unauthorised person/s or shall in any manner misconduct himself, his employment may be terminated forthwith and thereby all rights and advantages reserved to him by this Agreement shall cease.

16. This Agreement may be terminated by the Government at any time on one month's notice in writing or a payment of two weeks' salary.

17. The Policy Consultant may at any time after expiration of one month from the commencement of the Agreement date, terminate his engagement by giving one month's notice in writing or paying the Government two weeks' salary.

18. In the event of a change of Government or Minister, when the Policy Consultant would be expected to offer his resignation, the agreement may be terminated by either party forthwith. The Policy Consultant shall continue to receive the salary stipulated to the end of the month of such termination.

19. If the Policy Consultant determines his engagement otherwise than in accordance with this Agreement, he shall be liable to pay as liquidated damages one month's salary.

20. In the event of pecuniary damage arising from disregarding or failing to comply with any order, standing order, or instruction given by the Minister or from any neglect of duty whatsoever on his part, the Policy Consultant may be liable to a deduction from his salary to make good the damage or any part thereof, the amount of which shall be fixed by the Government.

21. Three months prior to the completion of service under this Agreement the Head of Secretariat has to determine whether this engagement is still required and informs the Head of Secretariat (OPM) accordingly.

22. If the Government offers him an extension for his engagement, this shall be on such terms and for such periods as may be mutually agreed upon.

The parties intending to be legally bound are therefore signing this Agreement on the date set hereunder.
